

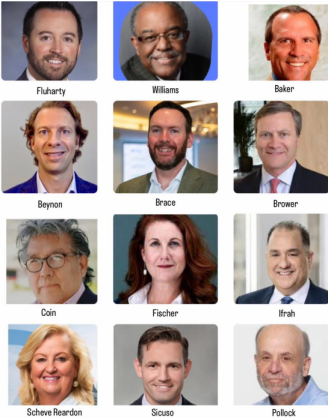

Gaming 101 Session to Kick Off NCLGS Summer Meeting in Louisville
